

Terms and Conditions for Fit by the Figure Competition Entry

- 1. Eligibility:** This competition is open to individuals who sign up for a 12-month subscription to the Fit by the Figure app at the discounted rate of \$149 (40% off) during the promotional period, which commences on 12th August and concludes on 9th September. By entering this competition, participants agree to be bound by these terms and conditions and confirm that all information provided is true, accurate, and complete. No refunds or free trial periods are available when signing up at the discounted rate during the competition period.
- 2. Promotional Period:** The competition begins on 12th August at 00:01 (AEST) and ends on 9th September at 23:59 (AEST). Subscriptions made outside of this time frame will not be eligible for entry into the competition.
- 3. How to Enter:** To enter the competition, participants must successfully sign up for a 12-month subscription to the Fit by the Figure app within the promotional period. Each subscription is considered as one entry into the draw. Participants are limited to one entry per person. Multiple subscriptions by the same person will be deemed invalid.
- 4. Prizes:** There are three prizes available:
 - 1st Prize: \$1000 plus a coaching call valued at \$150.
 - 2nd Prize: \$500 plus a coaching call valued at \$150.
 - 3rd Prize: \$250 plus a coaching call valued at \$150.

Prizes are not transferable and the coaching call is not exchangeable for cash. The decision on prize allocation is final and no correspondence will be entered into. The cash prizes will be transferred to the winners via PayPal. The free coaching call must be redeemed within 6 months of the competition ending.

Winners will be notified via the email address associated with their subscription and announced on the Fit by the Figure app and the Fit by the Figure stories. If a winner cannot be contacted or does not claim the prize within 14 days of notification, we reserve the right to withdraw the prize from the winner and pick a replacement winner.
